1. Call To Order

3. Reports

Secretary's Report - Chantel Kryzanowski:

In the year of 2020/2021, RES had a total of 10 monthly meetings from September 2020 – June 2021. Seven of these meetings occurred in the evening and 3 meetings were held over the lunch hour. All meetings were held virtually over Zoom with the current COVID-19 pandemic. Since the meetings occurred virtually, the RES Members in attendance had the option to order food for the meeting. The RES spent an average of \$59.44 per meeting for a total of \$594.41. On average, there were eleven RES members at each meeting. The RES continued to utilize the Funding Application Form for groups to request funding. All events were hosted virtually due to the COVID-19 pandemic.

Treasurer's Report - Kelsey Wells:

In the 2020-2021 financial year the Regina Engineering Society (RES) achieved a net profit of \$7,318.48 due to an increased grant from Association of Professional Engineers and Geoscientists of Saskatchewan (APEGS) and reduced expenditure from canceled events due to Covid-19. This is a difference of \$21,028.48 from the 2020-2021 approved budget as the approved budget had planned on a deficit of \$13,710.00. The RES income this year was funded 100% by the APEGS member grant, and only 34% of the planned budget expenses were used.

This year we were again limited in our ability to host events. However, we were able to host two online events centered on Intersectionality in Engineering and a Resume Development session. We were proud to use the majority of the budgeted RES funds for community sponsorship programs and events including funding for the Saskatchewan Scholastic Chess Association, the Western Engineering Competition, the U of R Solar Club project, and the Regina Engineering Student Society.

For the upcoming 2021-2022 Budget we have proposed an increase in spending due to offset our inability to spend the past two budgets. Increased budget items include the U of R Project day



awards fund, the community sponsorship funds, RES insurance, and RES communications fees. An overall deficit of \$15,485.00 is proposed for the 2021-2022 Financial Year.

Social Director's Report - Chantel Kryzanowski on behalf of Sarah Yeo:

The Regina Engineering Society held a few virtual events through the global coronavirus pandemic. The Virtual Holiday Mixer was held on December 18, 2020 and was held over Zoom. Food was ordered from the Italian Star Deli and delivered on the afternoon of December 18th to recipients who reserved tickets. There were 16 tickets sold for this event, and 3 people attended the event virtually. Donations were collected and \$60 was donated to the local shelter.

• Acting Technical Director's Report - Chantel Kryzanowski on behalf of Sarah Yeo:

The Regina Engineering Society held an Equity, Diversity, & Inclusion 101 for Engineers presentation on February 24, 2021, that was hosted by Meghana Valupadas, Engineer-in-Training in Alberta. This presentation introduced and explored the intersections of identity and how they relate to diversity, inclusivity, equity and privilege. We received lots of positive feedback from this event. This event was presented virtually over Zoom and had eighteen people in attendance.

The RES also presented an Ethics Talk virtually over Zoom on May 12, 2021. This seminar presented different scenarios in engineering environments and how to approach these scenarios with ethical values in mind. There were five people in attendance.

The last event of the year was a Job Searching for Engineers Workshop hosted by Sherry Knight on May 13, 2021. This seminar included tips and tricks on how to make your resume stand out in the current market. There was lots of positive feedback from this event. Going forward, the RES plans to explore new and dynamic ways to bring technical presentations to our members in the upcoming year.
